For more than three decades, Dr. Hensler has conducted research and written about public policy issues in the civil justice area within and outside the United States. Her empirical research on dispute resolution in ordinary and complex litigation and tort liability has won national recognition, and she has testified before state and federal legislatures in the U.S. and consulted with judicial and bar committees and task forces in North America, Europe and Asia regarding issues ranging from alternative dispute resolution to asbestos litigation, mass torts, and class actions. As a founding member of the RAND Institute for Civil Justice, she helped to establish its preeminent position as a center for empirical research in the U.S. on civil litigation issues, and during her tenure at Rand, she served first as the Institute's Research Director and then as its Director.
